No.F.51-1/2009-NCTE (N&S): In exercise of the powers conferred by sub-section (2) of section 32 of the National Council for Teacher Education Act, 1993, the National Council for Teacher Education in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2007 hereby makes the following regulations, namely: -

1. Short Title, Application and Commencement.-

- (1) These Regulations may be called the National Council for Teacher Education (Recognition Norms & Procedure) Regulations, 2009.
- (2) They shall come into force with effect from the date of their publication in the Official Gazette.

2. Definitions.-

In these regulations, unless the context otherwise requires, all the words and expressions used herein and defined in the National Council for Teacher Education Act, 1993 (73 of 1993) shall have the same meaning respectively as assigned to them in the said Act.

3. Applicability.-

These Regulations shall be applicable to all matters relating to teacher education programmes covering norms and standards and procedures for recognition of institutions, commencement of new programmes and addition to sanctioned intake in existing programmes and other matters incidental thereto.

(3) Admission Procedure

Admission shall be made on merit on the basis of marks obtained in the qualifying examination and/or in the entrance examination or any other selection process as per the policy of the State Government/U.T. Administration and the University.

(4) Fees

The institution shall charge only such fee as prescribed by the affiliating body / State Govt. concerned in accordance with provisions of National Council for Teacher Education (Guidelines for Regulations of tuition fees and other fees chargeable by unaided teacher education institutions) Regulations, 2002, as amended from time to time and shall not charge donations, capitation fee etc from the students.

4 Staff

(I) Academic

(i)	Number	(For a basic unit of one hundred students)
	Principal/Head	- One
	Lecturers	- Seven

(ii) For additional intake will be in the multiple of one hundred and the number of full time teacher educators shall be increased by seven for each increase in the basic unit. However on each occasion additional intake of one basic unit shall be considered. Also, maximum intake capacity of a teacher training institution taking all teacher education courses together shall not exceed three hundred.

(iii) Appointment of teachers shall be such as to ensure the availability of expertise for teaching all foundation and methodology courses

(II) Qualifications

(i) Principal/Head (in multi-faculty institution) :-

- (a) Academic and professional qualification will be as prescribed for the post of lecturer; and
- (b) Ph.D in Education
- (c) Ten years teaching experience out of which at least five years teaching experience in a Secondary Teacher Education Institution.

Note:- In the event of non-availability of eligible and suitable candidates for appointment as Principal/Head as per above eligibility criteria, it would be permissible to appoint retired Professor/Head in Education on contract basis for a period not exceeding one year at a time till such time the candidates complete 65 years of age.
